OUR FEES

The Firm has various methods of working with clients.

An initial consultation will be held to discuss the issue at hand. If there is a dispute, and it is agreed upon that the Firm will represent the client, the client would be required to sign a suitable legal power of attorney and the fees agreement. In general, the policy of the Firm is that an advance payment should be paid before commencing any suit. But this can be exempted in certain cases.

The client is given a copy of the documents which he signs and he also receives the receipt of any amount he pays. He is also given a statement of expenses and the judicial fees. A certain person at the Firm is assigned to the client with regard to his lawsuit. This is in addition to the liability of the Firm secretariat for notifying the client and answering any inquiries regarding the session dates of his legal action and their subsequent procedures. The client is always kept informed of the latest developments related to his case.

In the case of annual consultation contracts with companies and establishments, the office presents a regular report regarding all the lawsuits undertaken their procedures, the measures taken and the following procedures as well as an accounting list of all the works.
